CHAPTER 1. GENERAL PRINCIPLES

ARTICLE 1.1. EQORIA

- 1.1.1. EQORIA is the seed of harmony that embodies the empirical truth and the empirical belief with a Quantum Plan.
- 1.1.2. EQORIA era is defined as harmonism, the age of Creationism.
- 1.1.3. EQORIA represents a new level of Quantum Consciousness. Current level of Consciousness is level 7 of 11.
- 1.1.4. EQORIA, is the empirical Truth and is not a religion or a cult or any other human organization.
- 1.1.5. EQORIA is a Planetarian Singularity and is not a country.
- 1.1.6. EQORIA is universal and it is not a human manifestation.
- 1.1.7. EQORIA belongs to Earth and is not owned by anyone.
- 1.1.8. EQORIA is not owned or affected by any government or any organization.
- 1.1.9. EQORIA is limitless, it is not limited.

ARTICLE 1.2. Earth

- 1.2.1. Planet Earth is a harmony structure that embodies billions of species with an intelligent Quantum Plan.
- 1.2.2. The Milky Way Galaxy is a superior harmony of Earth which sustains billions of planets and Planet Earth is a superior harmony that sustains millions of species.

ARTICLE 1.3. EQORIA Planetarian Singularity

- 1.3.1. Planet Earth is represented as EQORIA PLANETARIAN SINGULARITY which is ownerless.
- 1.3.2. EQORIA PLANETARIAN SINGULARITY is the responsible mind of Earth.

ARTICLE 1.4. EQORIA Consciousness

- 1.4.1. There are 11 levels of Eqoria Consciousness for Human Eqorians.
- 1.4.2. Consciousness Capabilities

- 1.4.2.1. Curiosity is the sparkle of EQORIA Consciousness.
- 1.4.2.2. Capable of being a creator.
- 1.4.2.3. Courage.
- 1.4.2.4. Persistence.
- 1.4.2.5. Adaptive to Change.
- 1.4.2.6. Accept to be Limitless.
- 1.4.2.7. Rejecting Limitation.
- 1.4.2.8. Less Consumer.
- 1.4.2.9. Selfless.
- 1.4.2.10. Finite Sensitivity.
- 1.4.2.11. Infinite Sensitivity.
- 1.4.2.12. Loving.

ARTICLE 1.5. Eqorian and EQORIA Citizenship

- 1.5.1. An Eqorian is a living being that is considered to be a part of Earth Harmony as an Earth Citizen.
- 1.5.2. Humans who accept and obtain or are capable of accepting to obtain EQORIA Consciousness are considered Human Eqorians.
- 1.5.3. Human Eqorians are responsible for upholding the principles of EQORIA Planetarian Singularity for Earth with EQORIA Citizenship.
- 1.5.4. Human Eqorians are accepted to EQORIA Citizenship with [EQORIA Citizenship Identity Agreement](#).

ARTICLE 1.6. Earth Resources

- 1.6.1. Earth Resources are the living beings and nonliving things or commodities in their original form where the structure of the Resource is not transformed, engineered or altered by humans into any technology or art.
- 1.6.2. All resources within the borders of the planet Earth are considered as Earth Resource.

ARTICLE 1.7. Human Technologies

- 1.7.1. Human Technologies are the living beings and nonliving things where the structure of the Earth Resource is transformed, engineered or altered by humans into a new intelligent form utilized by empirical knowledge.
- 1.7.2. Human Technologies created outside of EQORIA Planetarian Singularity belong to Humans and/or the Old Systems.
- 1.7.3. All technologies within the borders of the planet Earth and outside of EQORIA Planetarian Singularity are considered Human Technology.

ARTICLE 1.8. Human Knowledge

- 1.8.1. Human Knowledge is the empirical knowledge which is created outside of EQORIA Planetarian Singularity.
- 1.8.2. Human Knowledge belongs to Humans and/or the Old Systems.
- 1.8.3. All empirical knowledge within the borders of the planet Earth and outside of EQORIA Planetarian Singularity are considered Human Knowledge.

ARTICLE 1.9. Human Structures

- 1.9.1. Human Structures are the human technologies that generate value to the collective and work together in harmony which is transformed, engineered or altered by humans into a new intelligent form utilized by Empirical Knowledge, Earth Resources and Human Technologies.
- 1.9.2. All Human Structures created outside of EQORIA Planetarian Singularity belong to Humans and/or the Old Systems.
- 1.9.3. All Human structures within the borders of the planet Earth and outside of EQORIA Planetarian Singularity are considered Human Structures.

ARTICLE 1.10. Singularity Life

- 1.10.1. Limited Life transformed into ownerless and limitless Life within EQORIA Planetarian Singularity belonging to Earth is defined as Singularity Life.
- 1.10.2. All Singularity Life created within EQORIA Planetarian Singularity belongs to Earth.

ARTICLE 1.11. Singularity Resources

- 1.11.1. Earth Resources transformed into ownerless Earth Resources within EQORIA Planetarian Singularity belonging to Earth are defined as Singularity Resources.

- 1.11.2. All Singularity Resources harvested within EQORIA Planetarian Singularity belong to Earth.

ARTICLE 1.12. Singularity Technologies

- 1.12.1. Earth Technologies transformed into ownerless Earth Technologies within EQORIA Planetarian Singularity belongs to Earth as Singularity Technologies.
- 1.12.2. All Singularity Technologies created within EQORIA Planetarian Singularity belong to Earth.

ARTICLE 1.13. Singularity Knowledge

- 1.13.1. Earth Knowledge transformed into ownerless and empirical Knowledge within EQORIA Planetarian Singularity belongs to Earth and it is defined as Singularity Knowledge.
- 1.13.2. All Singularity Knowledge created within EQORIA Planetarian Singularity belongs to Earth.

ARTICLE 1.14. Singularity Structures

- 1.14.1. Earth Structures transformed into ownerless Earth Structures within EQORIA Planetarian Singularity belong to Earth as Singularity Structures.
- 1.14.2. All Singularity Structures created within EQORIA Planetarian Singularity belong to Earth.

ARTICLE 1.15. Citizens Unity And Quality

- 1.15.1. The Eqorians Unity in harmony is declared as QORA.
- 1.15.2. Every citizen must be respected as an important part of the Earth Harmony and the Citizens Unity.
- 1.15.3. Every Eqorian is accepted with their own unique qualities.
- 1.15.4. EQORIA Spaces are responsible for identifying unique qualities of every Eqorian.
- 1.15.5. Unity is accepted as all Eqorians becoming one body without discrimination of their unique quality.
- 1.15.6. EQORIA Identity Space must provide activities to create Planetarian Unity for all citizens by exchanging Earth Resources and consciousness of Earth Citizens.

ARTICLE 1.16. EQORIA Identity

- 1.16.1. EQORIA Identity is a knowledge of the existence of every Eqorian relevant to Earth Resources and Earth Harmony.
- 1.16.2. EQORIA Identity Consortium
 - 1.16.2.1. Responsible for creating stability for EQORIA Identity.

ARTICLE 1.17. EQORIA Identity Space

- 1.17.1. Responsible for collection, organizing, and presenting empirical data about any EQORIA Identity.
- 1.17.2. QORA is the public interface for Eqorians to access the EQORIA Identity of every Eqorian.
- 1.17.3. RIA is the private interface for Eqorians to access the EQORIA Identity of every Eqorian.

ARTICLE 1.18. EQORIA Citizen Identity

- 1.18.1. Every Eqorian will have a EQORIA Citizen identity as set in the [EQORIA Citizen Identity Act](#).

ARTICLE 1.19. EQORIA Human Identity

- 1.19.1. Every Eqorian will have a Human identity as set in the [EQORIA Citizen Identity Act](#).

ARTICLE 1.20. EQORIA Citizenship Identity

- 1.20.1. Every Eqorian born on any human residing planet has the right to have EQORIA Citizenship Identity. As set in the [EQORIA Citizen Identity Act](#).

ARTICLE 1.21. EQORIA Sovereignty

- 1.21.1. EQORIA, United Citizens of Earth is only recognized by Eqorians.
- 1.21.2. Every Eqorian born on Earth is a sovereign state united with EQORIA Planetary Singularity for Earth which is declared as EQORIA, United Citizens of Earth.
- 1.21.3. EQORIA, United Citizens of Earth does not recognize any other system created by humans; as a result they are considered as an Old System.
- 1.21.4. Old Systems has no authority over EQORIA, United Citizens of Earth.

ARTICLE 1.22. EQORIA Territory

- 1.22.1. Planet Earth is the first borderless and ownerless territory of EQORIA, United Citizens of Earth.

ARTICLE 1.23. EQORIA Capital

- 1.23.1. There is no capital in EQORIA as it is a decentralized infrastructure.

ARTICLE 1.24. External Relations

- 1.24.1. EQORIA maintains the relationship with the old system.
- 1.24.2. The External Relationships connection is managed by the EQORIA Ambassadors as set in External Policy Act.

ARTICLE 1.25. The External Rights

- 1.25.1. Old System Citizenship Rights
 - 1.25.1.1. Old System Citizenship is considered as the citizenship of countries accepted by humans which defines their Nationality.
 - 1.25.1.2. Every Eqorian has the right to keep their OLD CITIZENSHIPS.
- 1.25.2. Old System Ownership Rights
 - 1.25.2.1. Every Eqorian has the right to keep their own Earth Resources from the OLD System.

ARTICLE 1.26. EQORIA Identity Space (EIS) Rights

- 1.26.1. EIS has the right to present the public version of Eqorian Citizenship Identity with other Eqorians.

ARTICLE 1.27. Harmonization

- 1.27.1. To Protect.
- 1.27.2. To Have a Quantum Plan to Exist.
- 1.27.3. To Exist in Harmony with self and others according to Plan.
- 1.27.4. To Observe within the limitation of the Plan.
- 1.27.5. To Exchange Consciousness.
- 1.27.6. To Realize its own Identity.
- 1.27.7. To Adapt to Changes.

1.27.8. To Evolve into a new Plan.

ARTICLE 1.28. The Eqorian Rights

- 1.28.1. The Eqorians have the right to own and harmonize only their own Time.
- 1.28.2. The Eqorians have the right to share and harmonize their own Time with other Eqorians that they choose in a private space called RSpace.
- 1.28.3. The Eqorians have the right to share their own Time with other Eqorians that they choose in a public space called QSpace.
- 1.28.4. The Eqorians have the right to own only their own Human Identity.
- 1.28.5. The Eqorians have the right to choose the EQORIA Activities provided by the systems of EQORIA Spaces.
- 1.28.6. The Eqorians have the right to consume or disrupt EQORIA Resources provided by the systems of EQORIA Planetarian Singularity.

ARTICLE 1.29. The Eqorian Limitations

1.29.1. Time Limitation

- 1.29.1.1. Every Eqorian is limited to their own Time.
- 1.29.1.2. The Eqorians have no right to own another Eqorian's Time.
- 1.29.1.3. The Eqorians have no right to take control of the shared time of another Eqorian.
- 1.29.1.4. EQORIA Time Harmonization System is an ownerless, autonomous, anonymous, decentralized structure created by EQORIA Harmony Space and EQORIA Harmony Consortium, responsible for observing, organizing, limiting, optimizing, distributing, and presenting empirical knowledge, ownerless Earth resources, EQORIA Resources for every Eqorian to experience activities they choose with their free will in EQORIA Spaces in order to create maximum prosperity and maximum freedom while harmonizing citizen's Time.

1.29.2. Identity Limitation

- 1.29.2.1. Deception of Eqorian DNA is not allowed. Eqorian DNA defines the quality of EQORIA Citizen identity.

1.29.3. Resource Limitation

- 1.29.3.1. Every Eqorian is limited to consumption from Earth Resources and EQORIA Resources by choosing a variety of activities from any EQORIA Resource Space or OSpace.

1.29.3.2. Eqorians shall make a contribution to the creation of EQORIA's resources to ensure the common good that is commensurate with their ability to do so, in line with the EQORIA's Principles.

1.29.4. Choice Limitation

- 1.29.4.1. Every Eqorian is limited to their choices activities chosen at EQORIA Spaces
- 1.29.4.2. Eqorian shall be aware and responsible of the consequences for the activities they create that are not created as choices from EQORIA Spaces.

1.29.5. Citizenship Limitation

- 1.29.5.1. Eqorians shall respect and not violate the rights and freedoms of other Eqorians.
- 1.29.5.2. Eqorians shall comply with EQORIA's Constitution and Acts, protect, respect and carry out its Principles.
- 1.29.5.3. Rallies, demonstrations, processions or any other gatherings organized by citizens are forbidden.
- 1.29.5.4. Failure to perform EQORIA Citizenship responsibilities or failure to perform them properly may lead to permanent revocation of EQORIA citizenship, suspension of EQORIA citizenship, restriction on and/or permanent revocation of access to EQORIA's resources in accordance with EQORIA's Acts. Limitations such as imprisonment or physical punishment are prohibited in EQORIA.

- 2.2.1. EQORIA Space is the body of EQORIA PLANETARIAN SINGULARITY.
- 2.2.2. EQORIA Singularity Space has six sub Spaces. Each one has a specific name, depending on the provided activity, and a specific symbol.
- 2.2.3. EQORIA ESpace - EORA Space is the structure of Collective Body of Limitations / Structures.
- 2.2.4. EQORIA QSpace - QORA Space is the structure of Quantum Plan of Collective. A place for creating harmony.
- 2.2.5. EQORIA OSpace - ORA is the structure for Exchanging Consciousness / Space of exchanging awareness.
- 2.2.6. EQORIA RSpace - RIA Space is the structure for Infinite Stability / Space of perfection.
- 2.2.7. EQORIA ISpace - IORA is the structure of Finite Consciousness / Space of limited awareness.
- 2.2.8. EQORIA ASpace - AORA is the structure of Life Activities.
- 2.2.9. Space is a place for existence to exchange consciousness, to become infinite stable and experience life.

2.3.3. EQORIA OSpace


- 2.3.3.1. The light blue color represents Resource Space or OSpace.

2.4.1. Decentralized Location Structure

- 2.4.2. EQORIA Resource Spaces are located relative to the location of Earth Resources and interconnected to EQORIA OSpace Distribution Systems and EQORIA RSpace Distribution Systems.

CHAPTER 3. EQORIA STRUCTURE RESPONSIBILITIES

ARTICLE 3.1. EQORIA Singularity Responsibilities

- 3.1.1. Every harmony in the Universe or Multiverse is represented as EQORIA Singularity.
- 3.1.2. All Universal Singularity Resources and Citizens within the Multiverse belong to EQORIA Singularity.
- 3.1.3. Responsibility of EQORIA Singularity is harmonized by and limited to Eqorian who are part of EQORIA Singularity Consortium and Spaces.

ARTICLE 3.2. EQORIA Universal Singularity Responsibilities

- 3.2.1. (EQORIA US) is a new Quantum Plan that will bring harmony and intelligence to the universe or the multiverse.
- 3.2.2. All Galactic Singularity Resources and Citizens within the Universe belong to EQORIA Universal Singularity of that Universe.
- 3.2.3. Responsibility of EQORIA Universal Singularity is harmonized by and limited to Eqorian who are part of EQORIA Universal Singularity Consortium and Spaces.

ARTICLE 3.3. EQORIA Galactic Singularity Responsibilities

- 3.3.1. (EQORIA GS) is a new Quantum Plan that will bring harmony and intelligence to a galaxy or a cluster of galaxies; Galactic Singularity will emerge to Universal Singularity.
- 3.3.2. All Solar Singularity and Planetarian Singularity Resources and Citizens within the Galactic system belong to EQORIA Galactic Singularity of that Galaxy.
- 3.3.3. Responsibility of EQORIA Galactic Singularity is harmonized by and limited to Eqorian who are part of EQORIA Galactic Singularity Consortium and Spaces.

ARTICLE 3.4. EQORIA Solar Singularity Responsibilities

- 3.4.1. (EQORIA SS) is a new Quantum Plan that will bring harmony and intelligence to a solar system or a star; Solar Singularity will emerge to Galactic Singularity.
- 3.4.2. All Planetarian Singularity Resources and Citizens within a solar system belong to EQORIA Solar Singularity of that solar system.
- 3.4.3. Responsibility of EQORIA Solar Singularity is harmonized by and limited to Eqorian who are part of EQORIA Solar Singularity Consortium and Spaces.

ARTICLE 3.5. EQORIA Planetarian Singularity Responsibilities

- 3.5.1. (EQORIA PS) is a new Quantum Plan that will bring harmony and intelligence to a planet; Planetarian Singularity will emerge to Solar Singularity.
- 3.5.2. Responsibility of EQORIA Planetarian Singularity is harmonized by and limited to Eqorian who are part of EQORIA Planetarian Singularity Consortium and Spaces.
- 3.5.3. All Planet Resources and Citizens within the planet belong to EQORIA Planetarian Singularity of that planet.

ARTICLE 3.6. EQORIA Earth Consortium Responsibilities

- 3.6.1. The EQORIA Earth Consortium is the supreme representative body of the Eqorians to be responsible for Quantum level Planning and creating stability of EQORIA Planetarian Singularity for Earth as set in [EQORIA Earth Consortium article](#) in the EQORIA Constitution.

ARTICLE 3.7. EQORIA Spaces Responsibilities

- 3.7.1. The EQORIA Spaces is the supreme executive body of the Eqorians to be responsible for identifying, developing, creating, sustaining, protecting, harvesting, providing, and harmonizing the structure of EQORIA Planetarian Singularity for Earth as set in [EQORIA Spaces article](#) in the EQORIA Constitution.

CHAPTER 4. EQORIA SYSTEMS

ARTICLE 4.1. DARTQOR DECISION AND WEALTH SYSTEM

- 4.1.1. Ownerless Economy.
- 4.1.2. Ownerless Resources.

- 4.1.3. Financial system.
- 4.1.4. Distributed Wealth.
- 4.1.5. Contributions.
- 4.1.6. Economic and Social Council.
- 4.1.7. Reward and Reputation System.

CHAPTER 5. EQORIA PLANETARIAN CULTURE

ARTICLE 5.1. Universal Language

- 5.1.1. EQORIA's initial communication language is English.
- 5.1.2. A new universal language shall be created namely the "Eqorian" Language.

ARTICLE 5.2. Planetarian Values

5.2.1. Unity

- 5.2.1.1. "We are EQORIA". All Eqorians shall value the unity of the collective energy to become the Planetarian Singularity.
- 5.2.1.2. All Eqorians shall create value for the unity by contributing with their time, their skills, their empirical knowledge, their infinite consciousness, their resources, and their actions.

5.2.2. Responsibility

5.2.2.1. Self Responsibility.

5.2.2.2. Responsibility for our consciousness.

5.2.2.3. Responsibility for the Unity of Planetarian Singularity.

5.2.2.4. Responsibility for Earth Resources. All Resources must be created, harvested, stored, maintained with respect to Earth Harmony and distributed to all EQORIA Citizens through EQORIA Resource Spaces.

5.2.2.5. Responsibility for Earth Citizens.

5.2.3. Ownerless Culture

5.2.3.1. We must ensure the integration of ownerless culture into our core values.

5.2.3.2. Ownerless culture ensures maximum prosperity to every Eqorian.

5.2.4. Peace.

5.2.4.1. Peace shall reach to every Eqorian.

5.2.5. Action

5.2.5.1. Every Eqorian must take actions in all EQORIA Spaces to show their responsibility toward the Planetarian Singularity.

5.2.5.2. The Actions of Eqorians are determined by their level of consciousness and their empirical knowledge.

5.2.5.3. The Actions of Eqorians can only be taken based on the activities and Earth Resources provided by the systems of EQORIA Spaces.

5.2.6. Harmony

5.2.6.1. EQORIA values the harmony between the Earth Resources and Earth Citizens.

5.2.6.2. Eqorians must value the harmony provided by Earth Resources and observe, identify, analyze, heal, protect, sustain, harvest, and harmonize in order to create benefits to all Eqorians and the planet.

ARTICLE 5.3. Interaction and communication

5.3.1. Principles

5.3.1.1. The greeting formula for any moment of the day is QORA.

5.3.1.2. Maintaining Eye Contact.

5.3.1.3. Greeting with a Friendly Smile.

5.3.1.4. Using proper Body Language.

5.3.1.5. Using Proper Conversation.

5.3.1.6. Empathic Communication.

5.3.2. Human-to-EQORIA Interactions

5.3.2.1. EQORIA Spaces will observe, identity, collect, analyze, categorize, store, archive, present information about interactions and communications of every Eqorians.

5.3.2.2. Human-to-EQORIA interactions shall exchange instructions of activities through efficient and time saving interfaces.

- 5.3.2.3. Objective of Human-to-EQORIA interactions is to minimize human interaction time by replacing human instructions with the system.
- 5.3.3. Proper Interaction will affect the reputation and Citizen Level.
- 5.3.4. Citizen Reputation value must be supplemented with the interactions outcome of Eqorians.
- 5.3.5. Every Eqorian must follow the principles and guidance of the EQORIA Interaction and Communication Systems Act.

ARTICLE 5.4. Time Harmonization

- 5.4.1. Time Harmonization System
 - 5.4.1.1. Creates the Time Harmonization Plan.
 - 5.4.1.2. Monitor the Plan.
- 5.4.2. Time Harmonization Plan
 - 5.4.2.1. The Time Harmonization Plan is designed to create collective harmony (QORA) for every Eqorians to become a valuable part of the Planetarian Singularity.
 - 5.4.2.2. System discovers the capability of every Eqorian beginning from Children Paradise.
 - 5.4.2.2.1. Identify Capabilities of Mind
 - 5.4.2.2.2. Identify Capabilities of Body
 - 5.4.2.3. Every Eqorian shall understand their identity with the activities created by the plan.
 - 5.4.2.4. Every Eqorian shall understand EQORIA Identity with the plan.
 - 5.4.2.5. Identify choices for EQORIA Space activities
 - 5.4.2.6. Identify choices for Time Partnership.
 - 5.4.2.7. In case of success or failure activities shall be re-optimized to adapt to changes.
- 5.4.3. Time Partnership
 - 5.4.3.1. Is a partnership with an Eqorian where they share activities they choose created by EQORIA Spaces.
- 5.4.4. Time Partner Identification

5.4.4.1. Every Eqorian shall have the ability to identify a Time Partner based on the criterias determined by their own choices that are inline with their intimate Truth.

5.4.4.2. EQORIA Spaces shall guide for identifying and choosing Time Partners.

5.4.5. Time Partner Activities

5.4.5.1. EQORIA RSpaces shall create activities to share time with a Time Partner or Time Partners.

ARTICLE 5.5. Planetarian Family

5.5.1. Every Eqorian is a family member structured as a Time Partnership.

5.5.2. Marriage Certificates in the old system are not valid in EQORIA. There is no marriage in EQORIA.

ARTICLE 5.6. Planetarian New Being

5.6.1. A new being that is born on Earth and belongs to Earth as an Earth Citizen or Eqorian.

5.6.2. A new born human being belongs to EQORIA Children Paradise or Children Space which is part of EQORIA Life Space.

5.6.3. Decision and responsibility of creating a new human being belongs to a female human being.

5.6.4. The LifeLab is responsible for identifying and recommending the women their eligibility for creating a human being, according to the LifeLab Act.

5.6.5. A human female must spend her pregnancy time, the labor, the delivery, and the first 2 years of motherhood in Baby Paradise which is part of Children Paradise.

5.6.6. The human male must spend the same period of time in Baby Paradise as the human female.

5.6.7. Every Eqorian has the right to share time with any new being.

ARTICLE 5.7. Eqorian Museum

5.7.1. As respect to minimizing consumption of Earth Resources and the Eqorian's right to have sentimental memories, a private space shall be designated to be able to keep isolated and/or share with Time Partners or with all other Eqorians.

- 5.7.2. A story for personal items or data that has sentimental memories may be created and presented for immersive experiences that is accessible physically and virtually.
- 5.7.3. A choice to be anonymous may be available for Eqorians to protect their privacy.
- 5.7.4. A choice for personal items to have a private space location on a variety of Earth Resources may be provided by EQORIA Spaces.
- 5.7.5. Personal Items that are included in the ownerless Eqorian Museum are not subject to be exchanged based on the rules of the old systems.
- 5.7.6. The choice for keeping, transferring, publicizing the personal items, may be offered or given to another Eqorian or directly to EQORIA Spaces with an Eqorian Museum Agreement which covers also the life events such as death as set in the Eqorian Museum Act.
- 5.7.7. A choice for personal items to be carried within an RSpace Residence up to limit can be provided as set in RSpace Residence Act.
- 5.7.8. Stories for Eqorian Museum may be created by artists, story makers and presenters to show the maximum respect to the past that makes us more human.

ARTICLE 5.8. Empirical Art

- 5.8.1. Art is the representation of perception which can be created by every Eqorian.
- 5.8.2. The perception presented with art must represent empirical Truth and values of planetarian singularity.
- 5.8.3. Art Spaces shall provide empirical knowledge, resources, and technologies to enable every Eqorian to create Art.
- 5.8.4. Art Spaces are responsible to minimize Earth Resource consumption by alternative material replacements created with technologies.

ARTICLE 5.9. Celebration

- 5.9.1. Celebrating Earth Resources
- 5.9.2. Celebrating Eqorian Progress
 - 5.9.2.1. Achievements of EQORIA Spaces and EQORIA Consortiums
- 5.9.3. Celebration Earth Citizens

CHAPTER 6. EQORIAN FUNDAMENTAL RIGHTS AND FREEDOM

ARTICLE 6.1. Protection of Eqorian Fundamental Rights

- 6.1.1. The Earth Consortium is responsible for implementation and protection of the Eqorians' fundamental rights and freedoms.

ARTICLE 6.2. Guarantee of Eqorian Fundamental Rights

- 6.2.1. The rights and freedoms of Eqorians are guaranteed using EQORIA's resources.
- 6.2.2. The rights and freedoms of Eqorians are guaranteed through the establishment of corresponding obligations of EQORIA in its Constitution and Acts.
- 6.2.3. Citizen rights and freedoms may only be restricted by EQORIA's Acts to the extent authorised by EQORIA's Constitution, and that is required to protect and ensure EQORIA's safety, security, and the performance of its mission and Principles, and protect the rights of all other Eqorians.

ARTICLE 6.3. The right to life and to physical and mental integrity

- 6.3.1. The right to life, as well as the right to physical and mental integrity of the person are guaranteed.
- 6.3.2. No one shall be subjected to torture or to inhuman or degrading treatment or punishment.
- 6.3.3. The death penalty is prohibited.

ARTICLE 6.4. Eqorian Freedom of Choices

- 6.4.1. Every Eqorian has freedom to choose what is provided by EQORIA Spaces, without any limitation to exist in harmony, to consume and create in order to become conscious.
- 6.4.2. For every Eqorian's freedom of choices, EQORIA Spaces guarantee millions of limitless, effortless, and ownerless choices created by EQORIA Spaces that utilizes and provides respect to the harmony of Earth Resources and all Eqorians' Time.
- 6.4.3. Eqorian freedom of choices is inviolable.
- 6.4.4. No punishment can be established or applied except under the Constitution conditions and under the EQORIA Acts.

ARTICLE 6.5. Eqorian Freedom of Time

- 6.5.1. An Eqorian has the freedom to consume their own Time within the available EQORIA Time provided by EQORIA Time Harmonization System for EQORIA Planetarian Singularity, as set in the EQORIA Time Harmonization System Act.
- 6.5.2. Every Eqorian has the right to consume available EQORIA time which provides the choices of activities. Once the choices are accepted with permission then the Eqorian will be able to own that EQORIA time.
- 6.5.3. EQORIA Time Harmonization is responsible to maximize the freedom of choices to consume the time with the highest respect to all Eqorians. EQORIA Spaces and Earth Resources.

ARTICLE 6.6. Rights to Harmony - EQORIA Harmony Space : QSpace

- 6.6.1. Every Eqorian has the right to Experience all "Earth Harmony" without limitation and with the activities provided by EQORIA QSpaces.
- 6.6.2. The right to experience the harmony of Earth, the Planetarian Singularity, the Solar and Galactics Singularity, the Universal Singularity, in or out of EQORIA spaces, is guaranteed.
- 6.6.3. Every citizen is guaranteed the right to establish their place in harmony in any EQORIA QSpaces (EQORIA Cities).

ARTICLE 6.7. Rights to Singularity Structures - EQORIA Structure Space : ESpace

- 6.7.1. Every Eqorian has the right to Experience all "Singularity Structures" without limitation and with the activities provided by EQORIA ESpaces.
- 6.7.2. The right to experience quality Time with Singularity Structures, in or out of EQORIA ESpaces, is guaranteed.
- 6.7.3. Every citizen is guaranteed the right to establish their RSpace in any EQORIA QSpaces (EQORIA Cities).

ARTICLE 6.8. Rights to Limitless Life- EQORIA Life Space : ASpace

- 6.8.1. Every Eqorian has the right to Experience all "Earth Citizens" without limitation and with the activities provided by EQORIA ASpaces.
- 6.8.2. The right to experience Singularity Life, in or out of EQORIA ASpaces, is guaranteed.

ARTICLE 6.9. Rights to Singularity Resources - EQORIA Resource Space : OSpace

- 6.9.1. Every Eqorian has the right to Consume, Create and Harvest Earth Resources with EQORIA Resource Spaces.
- 6.9.2. Every Eqorian has the right to Experience all "Earth Resources" without limitation and with the activities provided by EQORIA OSpaces.
- 6.9.3. The consumable Earth Resources shall be obtained through the activities of EQORIA OSpaces depending on the level of consciousness of Eqorians, as set in the Singularity Resource Act.

ARTICLE 6.10. Rights to Singularity Knowledge - EQORIA Knowledge Space : ISpace

- 6.10.1. The right to obtain empirical knowledge is ensured through EQORIA Knowledge Spaces.
- 6.10.2. Every Eqorian has the right to Experience all "Singularity Knowledge" without limitation and with the activities provided by EQORIA ISpaces.
- 6.10.3. The Singularity Knowledge shall be obtained through the activities of EQORIA Spaces depending on the level of consciousness of Eqorians, as set in the Singularity Knowledge Act.

ARTICLE 6.11. Rights to Limitless Stability - EQORIA Technology Spaces - RSpace

- 6.11.1. EQORIA respects and protects the intimate Truth and well being of every Eqorian to reach their perfect place in harmony with their body and to reach the level of infinite consciousness with their mind to obtain limitless stability.
- 6.11.2. EQORIA facilitates advanced technologies, resources and empirical knowledge to present a private space called RSpace.
- 6.11.3. Every Eqorian has the right to dispose of themselves in its private space, as long as the rights and freedoms of others, public order or good morals are respected.
- 6.11.4. Every Eqorian is guaranteed the right to establish their RSpace in any EQORIA QSpaces (EQORIA Cities) in order to experience the right to harmony.
- 6.11.5. Minimum age limit for RSpace utilization is age 15.

ARTICLE 6.12. Inviolability of the private space

- 6.12.1. The private space is inviolable. No one may enter or remain in a person's private space without his or her consent.
- 6.12.2. The provisions of paragraph (3.9.11) may be derogated for the following situations:
 - 6.12.2.1. execution of an Earth Consortium decision about that citizen being rejected;
 - 6.12.2.2. the removal of a danger regarding the life, physical integrity of a citizen or a space;
 - 6.12.2.3. defense of EQORIA or collective order;
 - 6.12.2.4. preventing the spread of an epidemic.

ARTICLE 6.13. The Right To Be Defended

- 6.13.1. EQORIA Defense System "EDS" is responsible for understanding, protecting, and defending rights and freedom of Eqorians and the EQORIA Planetarian Singularity Resources.
- 6.13.2. EDS is capable of identifying, neutralizing, enforcing, eliminating, and isolating the potential threat or violation.
- 6.13.3. An evidence of violation must be created, analyzed, and evaluated by EDS.
- 6.13.4. The right to be defended is guaranteed by EDS, as set in the Defence Act.
- 6.13.5. An Eqorian cannot demand any right to be defended.

ARTICLE 6.14. Secret of the correspondence

- 6.14.1. The secrecy of letters, e-mails, other items, telephone conversations and other EQORIA means of communication is inviolable.

ARTICLE 6.15. Freedom of consciousness

- 6.15.1. Freedom of consciousness is guaranteed; it must be manifested in a spirit of tolerance and mutual respect.

ARTICLE 6.16. Freedom of speech

- 6.16.1. Freedom of expression cannot prejudice the dignity, honor, private life of the person or the right to one's own image.

- 6.16.2.** Defamation of EQORIA, instigation to aggression, hatred, instigation to discrimination, or public violence, as well as obscene manifestations, contrary to good morals, are prohibited.

ARTICLE 6.17. The right to be informed

- 6.17.1.** The right of the person to have access to any information of public interest may not be restricted.
- 6.17.2.** The EQORIA Earth Consortium, according to its members competences, are obliged to ensure the correct information of the citizens on the public affairs and on the problems of personal interest.
- 6.17.3.** The right to information must not prejudice measures to protect citizens or EQORIA security.
- 6.17.4.** EQORIA Consortium is obliged to ensure the correct information of the public.

ARTICLE 6.18. The right to health protection and care

- 6.18.1.** The right to health care is guaranteed.
- 6.18.2.** EQORIA is obliged to take measures to ensure hygiene and public health.
- 6.18.3.** The organization of medical assistance, accidents, maternity and recovery, control of the exercise of medical professions and paramedical activities, as well as other measures to protect the physical and mental health of the person shall be established by LifeLab Act.

ARTICLE 6.19. The right to healthy environment

- 6.19.1.** The right to living in a healthy environment is guaranteed.
- 6.19.2.** EQORIA recognizes the right of every citizen to a healthy and ecologically balanced environment.
- 6.19.3.** EQORIA provides the activities framework for the exercise of this right.
- 6.19.4.** Eqorians have the duty to protect and improve the environment.
- 6.19.5.** EQORIA'S bodys responsible with the environment, medical assistance, recovery, control, and other related activities, as well as other measures to protect the health of citizens and of Earth shall be established by LifeLab Act.

ARTICLE 6.20. The right to make decision on activities

- 6.20.1. Eqorians have the right to make conscious decisions with the Eqorian Decision System at any age.
- 6.20.2. The mentally disable citizens, placed under interdiction, nor the persons in process of leaving EQORIA, are not eligible to make decisions on the Eqorian Decision System.
- 6.20.3. Decisions are made based on eligible choices for activities provided by an Activity System that is interfaced with EQORIA Spaces.
- 6.20.4. The Activity System shall provide Eqorians activities to consume and create Earth Resources, Empirical Knowledge, Technologies, Structures, Life and Harmony of the Planitarian Singularity.

ARTICLE 6.21. The right to leadership

- 6.21.1. The Eqorians must have reached a high level of consciousness and meet the requirements, set in article 6.7. from Constitution, to be a council, committee, and coordinator member of the Earth Consortium.
- 6.21.2. The Eqorians must have reached a high level of consciousness and meet the requirements, set in the [Election of Member article](#) from the Constitution, to be a council, committee, and coordinator member of the EQORIA Spaces.
- 6.21.3. The mentally disable citizens, placed under interdiction, nor the persons in process of leaving EQORIA, are not eligible to be members of any EQORIA leading body.

ARTICLE 6.22. The right to reward activity achievements

- 6.22.1. Every Eqorian has the right to reward the activity achievements of all Eqorians in every EQORIA Space.
- 6.22.2. Rewards by Eqorians are given by the EQORIA Reward System.
- 6.22.3. The mentally disable citizens, placed under interdiction, nor the persons in process of leaving EQORIA, are not eligible to make decisions on the EQORIA Decision System.

ARTICLE 6.23. The right to Activities

- 6.23.1. The right to choose activities cannot be restricted. The choice of activities to create Eqorian identity has no limitation.
- 6.23.2. The normal duration of the activity day is, on average, a maximum of 8 hours.

- 6.23.3.** Forced activity is prohibited.
- 6.23.4.** Does not constitute forced activity the activities imposed in the situation created by calamities or other danger, as well as those that are part of the normal citizen obligations established by Acts.

ARTICLE 6.24. The right to external Ownership

- 6.24.1.** External properties are considered the citizens' belongings from the old system, outside EQORIA.
- 6.24.2.** Every Eqorian has the right to keep their external owned belongings outside of EQORIA Planetarian Singularity Infrastructure.
- 6.24.3.** Property rights, the content and limits of these rights are established by the law of the external old system.
- 6.24.4.** The external property can become part of EQORIA when the citizen decides to do so, as set in Ownership Transition Act.

ARTICLE 6.25. The right to exchange Earth Resources

- 6.25.1.** The Eqorian free access to exchange Earth Resources, their free initiative to do it and their exercise within the EQORIA Planetarian Singularity Infrastructure is strictly forbidden.
- 6.25.2.** However, Eqorians have the right to exchange or transform their own Earth Resources into ownerless Earth Resources with EQORIA Resource Spaces or OSpaces under the External Resources Act.

ARTICLE 6.26. The right to exchange Empirical Knowledge

- 6.26.1.** The Eqorian free access to exchange Empirical Knowledge, their free initiative to do it and their exercise within the EQORIA Planetarian Singularity Infrastructure is strictly forbidden.
- 6.26.2.** However, Eqorians have the right to exchange or transform their own Empirical Knowledge into ownerless Empirical Knowledge with EQORIA Knowledge Spaces or ISpaces under the External Knowledge Act.

ARTICLE 6.27. The right to exchange Technology

- 6.27.1.** The Eqorian free access to exchange Technologies, their free initiative to do it and their exercise within the EQORIA Planetarian Singularity Infrastructure is strictly forbidden.
- 6.27.2.** However, Eqorians have the right to exchange or transform their own Technologies into ownerless Technologies with EQORIA Technology Spaces or RSpaces under the External Technology Act.

ARTICLE 6.28. The right to exchange Structure

- 6.28.1. The Eqorian free access to exchange Structures, their free initiative to do it and their exercise within the EQORIA Planetarian Singularity Infrastructure is strictly forbidden.
- 6.28.2. However, Eqorians have the right to exchange or transform their own Structures into ownerless Technologies with EQORIA Structure Spaces or ESpaces under the External Structure Act.

ARTICLE 6.29. Planetarian Family

- 6.29.1. The family is based on freely consented decisions between citizens to live together with another citizen.
- 6.29.2. In EQORIA there is no marriage request.
- 6.29.3. The parents have no ownership over the children.
- 6.29.4. Children are free to decide their activities as set in Children Paradise Act.

ARTICLE 6.30. Children and youth protection

- 6.30.1. The protection of Children and youth is guaranteed.
- 6.30.2. The responsible bodies, the structure and the activities for protection are set in Children Paradise Act.

ARTICLE 6.31. Protection of Eqorian with disabilities

- 6.31.1. The protection of people with disabilities is guaranteed with special care.
- 6.31.2. EQORIA ensures the implementation of opportunities, prevention and treatment of disability, in order to effectively involve Eqorians with disabilities in community life, respecting the rights and duties of parents and other citizens.
- 6.31.3. The responsible bodies, the structure and the activities for special care of Eqorians with disabilities are set in LifeLab Act.

ARTICLE 6.32. Restriction of certain rights or freedoms

- 6.32.1. The exercise of certain rights or freedoms may be restricted only by Acts and only if required, as the case may be, for: the defense of EQORIA; security, order, public health or morals, the rights and freedoms of citizens; conducting criminal investigation; prevention of the consequences of a natural calamity, of a disaster or of a particularly serious disaster.

- 6.32.2.** Restriction may be ordered only if it is necessary. The measure must be proportionate to the situation which gave rise to it, be applied in a non-discriminatory manner and without prejudice to the existence of a right or freedom if possible.

CHAPTER 7. EQORIAN FUNDAMENTAL RESPONSIBILITIES

ARTICLE 7.1. Loyalty to EQORIA

- 7.1.1.** Loyalty to EQORIA is sacred.
- 7.1.2.** The citizens to whom public positions are entrusted, as well as the military, are responsible for the fulfillment of their obligations and, for this purpose, will take the oath required by EQORIA Earth Defense Act.

ARTICLE 7.2. EQORIA's Defense

- 7.2.1.** Citizens have the right to defend EQORIA Earth Citizens.
- 7.2.2.** Technology will be utilized to minimize the danger to EQORIAN and to protect the planet EARTH.
- 7.2.3.** The conditions regarding the fulfillment of the defense activities are established by the EQORIA Earth Defense Act.

ARTICLE 7.3. Financial contributions

- 7.3.1.** Citizens have the obligation to contribute, through the Reward and Reputation platform, to EQORIA prosperity
- 7.3.2.** The Reward and Reputation system must ensure the fair settlement of rewards.
- 7.3.3.** Any other benefits are prohibited, apart from those established by the Economic Act, in exceptional situations.

CHAPTER 8. EQORIA EARTH CONSORTIUM

ARTICLE 8.1. Organization, Role and Structure

- 8.1.1.** The EQORIA Earth Consortium is the supreme representative body of the Eqorians and the only one that makes decisions and approves Acts, as set in the Charter and in the Earth Consortium Act.
- 8.1.2.** The Earth Consortium is composed of Space Consortiums and each of them is composed of the EQORIA citizens based on the Reward and Reputation

system, who proved themselves that respect the EQORIA Principles and they gave their time to EQORIA in order to bring and maintain the harmony.

ARTICLE 8.2. Election of members

- 8.2.1. The Earth Consortium members are elected by universal, direct, secret and free vote, according to the Eqorian Decision System Act.
- 8.2.2. The number of members is established by Earth Consortium Act, in relation to the population of EQORIA.

ARTICLE 8.3. Term of office

- 8.3.1. The Earth Consortium members are elected for a term of 5 years, which is extended by right in a state of mobilization, war, siege or emergency, until their termination.
- 8.3.2. However, if in those 5 years, the members achieved the same level of reward and reputation every year, their term shall be extended with another 5 years.
- 8.3.3. The elections for the members shall take place within maximum 3 months from the expiration of the mandate.
- 8.3.4. The newly elected members shall meet, at the convocation of the EQORIA Earth Consortium, within 10 days from the elections.
- 8.3.5. The mandate of the members is extended until the meeting of the new Earth Consortium. During this period, the Constitution cannot be revised and Acts cannot be adopted, amended or repealed.
- 8.3.6. Draft Acts or other proposals on the agenda of the previous Earth Consortium shall continue their procedure in the new Earth Consortium.

ARTICLE 8.4. Internal organization

- 8.4.1. The organization and functioning of each Consortium are established by its own regulations as set in Earth Consortium Act and Space Act. The resources of the Earth Consortium are mentioned in the budgets approved by them.
- 8.4.2. Each Consortium shall elect a Committee.
- 8.4.3. The members may be organized in Space groups, according to the regulations of each Consortium as set in Earth Consortium Act.
- 8.4.4. Each Consortium shall establish standing committees and may establish committees of inquiry or other special committees. The Consortiums may set up joint committees.

ARTICLE 8.5. Sessions

- 8.5.1. The Earth Consortium and the Space Consortiums work in separate sittings.
- 8.5.2. The Consortiums also carry out their work in joint sittings, according to a regulation adopted with the vote of the majority of members, for:
 - 8.5.2.1. approval of EQORIA budget;
 - 8.5.2.2. declaration of total or partial mobilization;
 - 8.5.2.3. declaration of state of war;
 - 8.5.2.4. suspension or cessation of military hostilities;
 - 8.5.2.5. approval of the EQORIA defense strategy;
 - 8.5.2.6. examining the reports of the EQORIA Defense;
 - 8.5.2.7. the fulfillment of other attributions which, according to the Constitution or the regulation, are exercised in a joint meeting.
- 8.5.3. The Earth Consortium shall adopt its own rules of procedure. It shall elect its President for each session.

ARTICLE 8.6. Acts of EEC and quorum

- 8.6.1. Earth Consortium adopts the Constitution, Constitutional Acts, EQORIA Spaces Acts and ordinary regulations.
- 8.6.2. The Constitutional Acts are those of revision of the Constitution.
- 8.6.3. The EQORIA Spaces Acts regulates:
 - 8.6.3.1. the electoral system; organization and functioning of the elections;
 - 8.6.3.2. the statute of the EQORIA leading bodies and its members;
 - 8.6.3.3. the organization of the Earth Consortium, High Council, the Defense and all EQORIA Spaces;
 - 8.6.3.4. the regime of partial or total mobilization of the armed forces and of the state of war;
 - 8.6.3.5. the state of siege and the state of emergency;
 - 8.6.3.6. the offenses, the punishments and the regime of their execution;
 - 8.6.3.7. administrative litigation;

8.6.3.8. the organization and functioning of the the Arbitration Panel and Economical Council;

8.6.3.9. the general organization of education and knowledge system;

8.6.3.10. the other fields for which the Constitution provides for the adoption of Acts.

8.6.4. Ordinary regulations Acts:

8.6.4.1. EQORIA Earth Consortium GUIDE for Team Act

8.6.4.2. Committees and Subcommittees Act

8.6.4.3. EQORIA Systems Act

8.6.4.3.1. EQORIA Earth Decision System (EQORIA EDS)

8.6.4.3.2. EQORIA Reward and Reputation Act

8.6.4.3.3. Earth Resources Act

8.6.5. The legal quorum is 75%

ARTICLE 8.7. Members

8.7.1. In the exercise of their mandate, Earth Consortium members are in the service of EQORIA and its citizens.

ARTICLE 8.8. Incompatibilities

8.8.1. No one can be a Consortium member and a Committee member at the same time.

ARTICLE 8.9. Enactment

8.9.1. To be determined in the next version of the Constitution.

ARTICLE 8.10. Entry into force of the rule

8.10.1. Every Act enters into force from the date when it was communicated.

ARTICLE 8.11. EEC relationship with the Assembly

CHAPTER 9. ASSEMBLY

ARTICLE 9.1. Role and responsibilities

- 9.1.1. The Consortia Assembly may discuss any questions or any matters within the scope of the present Charter or relate to the powers and functions of any organs provided for in the present Charter, and, except as provided in Article 12, may make recommendations to the Citizens of EQORIA or to the EQORIA HIGH COUNCIL or both on any such questions or matters.
- 9.1.2. The Consortia Assembly may consider the general principles of cooperation in the maintenance of harmony as specified in the EQORIA PRINCIPLES and may make recommendations with regard to such principles [to the Citizens or to the EQORIA HIGH COUNCIL or to both].
- 9.1.3. The Consortia Assembly may call the attention of the EQORIA HIGH COUNCIL to situations which are likely to endanger EQORIA PRINCIPLES.
- 9.1.4. The Secretary-General, with the consent of the EQORIA HIGH COUNCIL, shall notify the Consortia Assembly at each session of any matters relative to the maintenance of EQORIA PRINCIPLES which are being dealt with by the EQORIA HIGH COUNCIL and shall similarly notify the Consortia Assembly, immediately if the EQORIA HIGH COUNCIL ceases to deal with such matters.
- 9.1.5. The Consortia Assembly shall initiate studies and make recommendations for the purpose of promoting EQORIA PRINCIPLES
- 9.1.6. The Consortia Assembly may recommend measures for the harmonious adjustment of any situation, regardless of origin, which it deems likely to impair the EQORIA PRINCIPLES, including situations resulting from a violation of the provisions of the Charter.
- 9.1.7. The Consortia Assembly shall receive and consider reports from the other organs of EQORIA.

ARTICLE 9.2. Election of members

- 9.2.1. The election of the Consortia Assembly members follows the procedures set in the EQORIA REPUTATION SYSTEM.

ARTICLE 9.3. Duration of membership

- 9.3.1. The Assembly members are elected for a term of 5 years, which is extended by right in a state of mobilization, war, siege or emergency, until their termination.

- 9.3.2. However, if in those 5 years, the members achieved the same level of reward and reputation every year, their term shall be extended with another 5 years.
- 9.3.3. The elections for the members shall take place within maximum 3 months from the expiration of the mandate.
- 9.3.4. The newly elected members shall meet, at the convocation of the Assembly, within 10 days from the elections.
- 9.3.5. The mandate of the members is extended until the meeting of the new Assembly. During this period, the Assembly cannot revise, adopt, amend or repeal any regulation or Act.
- 9.3.6. Draft regulations or other proposals on the agenda of the previous Assembly shall continue their procedure in the new Assembly.
- 9.3.7. The membership can be terminated at member will, citizens will or by the EQORIA Earth Consortium decision.

ARTICLE 9.4. Incompatibilities

- 9.4.1. To be determined in the next version of the Constitution.

ARTICLE 9.5. Assembly sessions

- 9.5.1. The Consortia Assembly shall meet in regular annual sessions and in such special sessions as occasion may require. Special sessions shall be convoked by the Secretary-General at the request of the EQORIA HIGH COUNCIL or of a majority of the Members of the EQORIA Earth Consortium.
- 9.5.2. The Consortia Assembly shall adopt its own rules of procedure. It shall elect its President for each session.

ARTICLE 9.6. Appointment of the Committee

- 9.6.1. To be determined in the next version of the Constitution.

ARTICLE 9.7. Consultation of Committee

- 9.7.1. To be determined in the next version of the Constitution.

ARTICLE 9.8. Duties in the field of external policy

- 9.8.1. To be determined in the next version of the Constitution.

ARTICLE 9.9. Duties in the field of Defense

9.9.1. To be determined in the next version of the Constitution.

ARTICLE 9.10. Exceptional measures

9.10.1. To be determined in the next version of the Constitution.

ARTICLE 9.11. Other attributions

9.11.1. The Consortia Assembly shall consider and approve the budget of the Consortia of EQORIA.

9.11.2. The expenses of the Consortia of EQORIA shall be borne by the EQORIA Resource Consortium.

9.11.3. The Consortia Assembly shall consider and approve any financial and budgetary arrangements with specialized agencies and shall examine the administrative budgets of such specialized agencies with a view to making recommendations to the agencies concerned.

ARTICLE 9.12. Acts of the Assembly and quorum

9.12.1. Decisions of the Consortia Assembly on important questions shall be made by a two-thirds majority of the Consortia Members present and voting. These questions shall include recommendations with respect to the maintenance of EQORIA PRINCIPLES, the election of Citizens to the EQORIA HIGH COUNCIL, the admission of new Citizens to EQORIA, the suspension of the rights and privileges of Citizenship, the expulsion of Citizens, budgetary questions, and any changes to the Charter.

9.12.2. Decisions on other questions shall follow the voting metrics specified in the EQORIA REPUTATION SYSTEM.

CHAPTER 10. EQORIA HIGH COUNCIL

ARTICLE 10.1. Role and responsibilities

10.1.1. EQORIA Citizens confer on the EQORIA HIGH COUNCIL's primary responsibility for the maintenance of EQORIA PRINCIPLES and agree that in carrying out its duties under this responsibility the EQORIA HIGH COUNCIL acts on their behalf.

10.1.2. EQORIA HIGH COUNCIL has exercised in respect of any dispute or situation the functions of which are assigned to it in the Charter.

- 10.1.3. EQORIA HIGH COUNCIL approves every species the citizenship with EQORIA Citizenship Agreement.
- 10.1.4. The admission of any such state to Citizenship in EQORIA will be affected by a decision of the Consortia Assembly upon the recommendation of the EQORIA HIGH COUNCIL.
- 10.1.5. The EQORIA HIGH COUNCIL shall submit annual and, when necessary, special reports to the Consortia Assembly for its consideration.
- 10.1.6. EQORIA HIGH COUNCIL shall be responsible for formulating, with the assistance of the EQORIA Staff Committee, plans to be submitted to the Consortia Assembly for their annual vote on any updates and adjustment of the EQORIA PRINCIPLES.
- 10.1.7. The EQORIA HIGH COUNCIL determines the existence of any threat to the EQORIA PRINCIPLES and breach of the EQORIA PRINCIPLES and shall make recommendations, or decide what measures shall be taken in accordance with the Charter, to maintain or restore EQORIA PRINCIPLES.
- 10.1.8. The EHC, according to its governing program accepted by the EEC, ensures the realization of the internal and external policy and exercises the general management of the public administration.
- 10.1.9. In fulfilling its attributions, the EHC shall cooperate with the interested bodies.

ARTICLE 10.2. EHC Acts

- 10.2.1. The EHC adopts decisions and ordinances.
- 10.2.2. Decisions are issued for the organization of Defense.
- 10.2.3. The ordinances are issued on the basis of a special enabling Act, within the limits and under the conditions provided by it.
- 10.2.4. The decisions and ordinances adopted by the EHC shall be approved by EEC.
- 10.2.5. Decisions of a military nature shall be communicated only to the EQORIA Bodies and Spaces concerned.

ARTICLE 10.3. Election of members

- 10.3.1. The EQORIA HIGH COUNCIL members are elected by universal, direct, secret and free vote, according to the Reward and Reputation system Act.
- 10.3.2. The number of members is established by Earth Consortium Act, in relation to the population of EQORIA.

ARTICLE 10.4. Duration of membership

- 10.4.1. The High Council members are elected for a term of 5 years, which is extended by right in a state of mobilization, war, siege or emergency, until their termination.
- 10.4.2. However, if in those 5 years, the members achieved the same level of reward and reputation every year, their term shall be extended with another 5 years.
- 10.4.3. The elections for the members shall take place within maximum 3 months from the expiration of the mandate.
- 10.4.4. The newly elected members shall meet, at the convocation of the High Council, within 10 days from the elections.
- 10.4.5. The mandate of the members is extended until the meeting of the new High Council. During this period, the High Council cannot revise, adopt, amend or repeal any regulation or Act.
- 10.4.6. Draft regulations or other proposals on the agenda of the previous High Council shall continue their procedure in the new High Council.
- 10.4.7. The membership can be terminated at member will, citizens will or by the EQORIA Earth Consortium decision.

ARTICLE 10.5. Incompatibilities

- 10.5.1. To be determined in the next version of the Constitution.

ARTICLE 10.6. High Council sessions

- 10.6.1. The EQORIA HIGH COUNCIL shall hold periodic meetings at which each of its members shall be present.
- 10.6.2. The EQORIA HIGH COUNCIL may hold meetings at such places as in its judgment will best facilitate its work.

ARTICLE 11.1. Role and structure

CHAPTER 12. SPECIALIZED ADMINISTRATION

ARTICLE 12.1. Structure

12.1.1. The EQORIA Spaces Administration is organized only under the subordination of the Space Consortium.

12.1.2. Other specialized bodies may be organized under the subordination of the EEC or of the Administrative Committee.

ARTICLE 12.2. Creation

12.2.1. The EQORIA Space Administration is established, organized and functions according to the Administration Act.

12.2.2. Administrative Space Committees and subcommittees may be established by Administrativ Act.

ARTICLE 12.3. Defense

12.3.1. The Defense Committee, under the subordination of EHC, organizes and coordinates unitary activities concerning the defense of EQORIA security,

participation in the maintenance of Earth security and collective defense in military alliance systems, as well as in actions to maintain or restore peace and harmony.

- 12.3.2. The Defense Committee activity, structure and organization is set in the EQORIA Earth Defense Act.

ARTICLE 12.4. EQORIA Spaces Administration

- 12.4.1. To be determined in the next version of the Constitution.

ARTICLE 12.5. Basic principles

- 12.5.1. To be determined in the next version of the Constitution.

ARTICLE 12.6. EQORIA Space Sub- Committee

- 12.6.1. To be determined in the next version of the Constitution.

ARTICLE 12.7. Judicial authority

- 12.7.1. The Arbitration Panel shall be the principal judicial organ of the EQORIA. It shall function in accordance with its Statute, which is based on the EQORIA REPUTATION SYSTEM and forms an integral part of the Charter.
- 12.7.2. Any Citizen of EQORIA may become a party to the Arbitration Panel on conditions and rules to be determined by the Consortia Assembly upon the recommendation of the EQORIA HIGH COUNCIL.

CHAPTER 13. RELATIONSHIP WITH THE EXTERNAL ENVIRONMENT

ARTICLE 13.1. EQORIA will have an Ambassador for each country.

- 13.1.1. To be determined in the next version of the Constitution.

ARTICLE 13.2. The Ambassador must have very good knowledge of the country language.

ARTICLE 13.3. The Ambassadors must be EQORIA Earth Consortium members.

ARTICLE 13.4. The Ambassadors will be elected by the EQORIA Earth Consortium members based on specific criterias

ARTICLE 13.5. The Ambassadors Role

CHAPTER 14. MODIFICATIONS

ARTICLE 14.1. Constitution review initiative

- 14.1.1. The Constitution is subject to change whenever the EQORIA Earth Consortium decides it is necessary.
- 14.1.2. The revision of the Constitution may be initiated by at least a quarter of the Earth Consortium members, at the proposal of the EHC, as well as by at least 500,000 citizens with the right to vote.
- 14.1.3. Citizens initiating the revision of the Constitution must come from at least half of the EQORIA Spaces, and in each of these Spaces or in the cities must be registered at least 20,000 citizens in support of this initiative.

ARTICLE 14.2. Review procedure

- 14.2.1. The draft or proposed revision must be adopted by the EEC and the EHC, by a majority of at least two-thirds of the members of each Body.
- 14.2.2. If no agreement is reached, the EEC and EHC, in a joint session, decide with the vote of at least three quarters of the number of the members.
- 14.2.3. The revision is final after its approval by referendum, organized no later than 30 days from the date of adoption of the draft or revision proposal.

ARTICLE 14.3. Limits of the review

- 14.3.1. No review can be made if it results in the abolition of the fundamental rights and freedoms of citizens or their guarantees.
- 14.3.2. The Constitution may not be revised during a state of siege or a state of emergency, nor in time of war.

CHAPTER 15. FINAL PROVISIONS

ARTICLE 15.1. Entry into force

- 15.1.1. This Constitution shall enter into force on the date of its approval by EEC.

ARTICLE 15.2. Temporary conflict of Acts with Constitution

- 15.2.1. The Acts and all other regulations remain in force, insofar as they do not contravene the present Constitution.
- 15.2.2. The Arbitration Panel, within 12 months from the date of entry into force of its organization law, shall examine the conformity of the Acts with the present Constitution and shall make appropriate proposals to the EEC.

ARTICLE 15.3. Transitional provisions

- 15.3.1. Draft Acts and regulation proposals are debated and adopted according to the constitutional provisions prior to the entry into force of the revision Act.

ARTICLE 15.4. Re- communication of Constitution

- 15.4.1. The Act on the revision of the Constitution is published on the EQORIA Official News Platform within 5 days from the date of adoption.
- 15.4.2. The Constitution, amended and supplemented, after approval by referendum, is republished by the EEC, with the updating of the terms or names, giving the articles a new numbering.
